The Joe Raso Hospice Residence completed its ninth year in operation in 2021 and remained a vital part of United Hospice, serving 242 patients and families. Able to provide both residential and inpatient levels of care, the JRHR team serves some of the highest acuity and neediest patients in our program.


Volunteers that have returned assist in many different roles and activities, such as picking up PPE supplies to organize and prepare for distribution for patient caregivers. Volunteers who indirectly assist in our offices by answering phones, entering data, putting together patient information packets, typing and filing are all directly involved with assisting families and a vital part of the care team. Other volunteers work directly caring for hospice patients, giving support to their family members and to their caregivers, in the community and at the Joe Raso Hospice Residence.

In 2021, Volunteers provided 2,091.75 hours of service.

Spiritual Care

Our spiritual care coordinators (SCC) journey with patients, provide support for staff, assist in memorial services and other religious rites that are meaningful. We uphold the importance of holistic care of individuals by addressing the connections between physical, psychological, and spiritual well-being. Regardless of faith belief (or lack of faith belief), they provide a listening ear and a compassionate presence. Part of their role as spiritual care coordinators was to represent UH and be a resource for end-of-life care in the clergy community.

Our spiritual care coordinators provided incredible support to the community during COVID, at times being the only clergy to respond to support families in critical times.



Social Work

The United Hospice social work staff provided ongoing psychosocial assessments, emotional support for anticipatory grief reactions, psychoeducation, advocacy for patients, families, and the interdisciplinary team.

The ongoing development of a plan of care that included specific goals, interventions for therapeutic outcomes, played a critical role in helping patients and families adjust to the hospice plan of care. Their hard work and unwavering dedication enhanced the delivery of care by identifying the need for non-pharmacological approaches to pain and symptom management from other team members such as direct care volunteers, massage or a music therapist.

UH social workers continued to link patients and families with community agencies, for example, the Veteran's Administration, County Offices of the Aging in both Rockland and Orange, and County Social Service Departments. These partnerships continued to help facilitate the successful application for Medicaid benefits, caregiver respite services, increase in Medicaid managed long-term care home health aide hours, funeral planning (including arranging for a DSS burial for the isolated patient or indigent families).

UH Social work staff play a critical role in assisting all patients and families completing advance directives that include discussions about choosing a healthcare proxy and or power of attorney.

Community

Services

Hope & Healing Center

UH's bereavement support programs provided an array of support services to our hospice families as well as bereaved persons in the community. Adult bereavement groups (for loss of a spouse and/or parent and sibling) and Healing Hearts were able to hold in-person and group sessions to meet the needs of those that have lost a loved one.

Healing Hearts served fifteen children that have experienced loss. The sessions included engaging and therapeutic activities. During one Healing Hearts session the children were reading a book entitled The Memory Box A Book About Grief by Joanna Rowland. The story is based upon a young girl who is grieving the loss of her family member. She then decides to make a memory box in which she then places special mementos such as photos, post cards, birthday cards and souvenirs. During the Healing Hearts group, each child was given the opportunity to select a box of their choice and decorate it with paint, photos, stickers etc. One child shared that she and her father had always planned to go to Universal Studios, but he died before they were able to go. She decorated her box with Universal themed items and clouds and rainbows.



Another project was the making a collage of "things we did together" and a "collage of feelings." The children gathered in a circle on the floor and feelings cards were placed face down. Each child took multiple turns picking up feelings cards to either keep or choose a new one based upon how they have felt or were feeling. Many of the children shared that they often felt their families were too busy and adults did not initiate conversations about their deceased loved ones. A child shared that "when I come to Healing Hearts, I feel like nothing bad will happen anymore and that I am safer."

Individual Bereavement Counseling

UH provided individual counseling and support for hospice families and community bereaved. In additional to the employed staff, UH provided clinical oversight of several mental health counseling interns and post-Master of Counseling graduates (that are fulfilling the required hours necessary to allow them to sit for their license). Each intern carried a small bereavement caseload and group work with minimum of one hour of supervision per week.

Marketing & Community Outreach

Our organizational mission of "Honoring Life, Giving Care and Bringing Comfort" was a guide for our outreach activities. By educating the community as well as healthcare providers, our goal is to improve end-of-life care through education and outreach with specific focus on outreach to underserved communities.

Addressing Health Disparities

The Mother Cabrini Health Foundation supported our ongoing efforts at engaging underserved communities in Orange and Rockland counties. With a focus on Hispanic patients and their family members, United Hospice continued with Spanish advertising and marketing in places of worship, digital advertising and in print. With the assistance from the foundation, we continued to make inroads where our mission aligns with community values, but myths about hospice care persists. Throughout the year, we ensured that patients who choose hospice could receive care in their language of their preference with our multi-lingual staffing.

Non-Profit & Community Collaborations


United Hospice continued its relationship with several local non-profit providers throughout 2021. United Way, Literacy Solutions, Haverstraw Collaborative, Rockland Immigration Coalition, Healthy Haverstraw, Spring Valley Collaborative, Rockland County OFA, Quisqueya Sports Club, MLK Center, Blauvelt Library, Orangeburg Library, Nanuet Library, Palisades Library, Pearl River Library, Piermont Library, and Sloatsburg Library were all contacted by the marketing team.

Faith-Based Outreach

Faith-based outreach and advertising continued throughout 2021 with outreach to places of worship throughout Rockland and Orange counties. Advertising in local bulletins was supported through grant funds.

Rebranding Project

United Hospice took advantage of the limited face-to-face access that remains present throughout our referral base to undergo a significant rebranding and website redesign. While United Hospice previously dropped the "of Rockland" from its name to support the growth in Orange County, an area that it has always served, the logo and styling remained significantly unchanged. Workshopping our logo, brand and meaning with line staff members, board members and leadership a logo, color scheme and font set were decided upon. The project of our rebranding continued to a complete website redesign and overhaul of our printed materials and collateral.






